Since this happen on a Friday the mold inspection people couldn't come out til the following Monday, when they arrived to my apartment they instantly saw all the mold on the outside of the entire building, when coming inside the apartment to do all their testing they saw the infected areas clearly that I had showed to the head maintenance worker. I got the mold report back on 1/1/2025, on the report it states there is fungal mold in the whole apartment.
