SUBJECT: Clean and Safe Team Homeless Actions and Outcomes – March 2026

The City of Reno continues to address homeless-related concerns and provide outreach to the unsheltered community within city limits through the Clean and Safe Team. This interdepartmental team plays a critical role in addressing the multifaceted challenges and community impacts associated with homelessness, while coordinating multiple concurrent efforts and programs to ensure a comprehensive, citywide response.

March Updates

- **Reno Housing Authority Motel Assistance Program:** In March, Clean and Safe Outreach facilitated 1 individual into the Motel Assistance program. One individual successfully transitioned out of the Motel Assistance Program into permanent housing.
- **Camera Mobile Trailers:** Clean and Safe’s Mobile Camera Trailer Pilot Program is ongoing. The mobile trailers continue to keep previously chronic areas clear and serve as a deterrent. The trailers are currently installed at Spokane Street, along the railroad and Galletti Way, along the railroad.

Multiple departments partake in standing or topic specific meetings with regional partners to help address homelessness, identify support, and advance collaborative, solution-oriented initiatives. March highlights are as follows:

Phone Call	1	0	Clean and Safe Outreach spoke with a father who was seeking motel assistance for himself, daughter, and granddaughter. Our Place was suggested and the father agreed to explore the option. After connecting with Our Place, staff confirmed the daughter and granddaughter are on the Our Place waitlist. Clean and Safe followed up with the father to inquire if they are interested in reuniting with family in Sacramento, as his daughter has a plan moving forward. Father declined reunification and plans to stay with daughter until they move into Our Place.
EconoLodge	2	2	Clean and Safe Outreach transported a couple's personal belongings from Siegel Suites - Nevadan to EconoLodge, as they did not qualify for Siegel Suites - Nevadan. The couple was housed through the Reno Housing Authority Motel Assistance Program, while they await permanent housing in April.
Siegel Suites - Nevadan	1	1	Clean and Safe Outreach connected with a client enrolled in the Reno Housing Authority Motel Assistance Program to discuss housing options. During the check-in, the client shared their medical concerns. Plan is to have UNR StreetMed Team follow up to treat wounds.
Housing and Homeless Services Case Conferencing	0	0	Clean and Safe Outreach referred two individuals to Safe Camp and were approved by the outreach teams. One individual moved in on March 11, while the other opted to move in with friends.

Referred individual to the Telemedicine Kiosk at Cares Campus for ongoing concerns.
Siegel Suites - El Cortez	1	1	Clean and Safe Outreach returned belongings to client that were stored at Safe Camp, as the client was unable to retrieve them within the 7-day window due to being hospitalized.

The individual shared they previously worked with RISE and are interested in reconnecting. Clean and Safe Outreach reconnected the individual with their previous outreach worker to follow up and explore potential housing options.
Safe Camp	1	1	Clean and Safe Outreach transported a client and their dog to Cares Campus for a Safe Camp intake. The client and their dog successfully moved into Safe Camp on March 11.
Sage Street & Railroad	2	0	The Reno Police Department requested Clean and Safe Outreach for a veteran seeking services. The individual reported being on a 30-day sit-out from the Cares Campus and stated they are not interested in permanent housing, as they have a vacant lot in Winnemucca, Nevada, where they plan to build housing. Clean and Safe offered a bus ticket for reunification with proof of ownership of the property, but the individual declined as they are waiting for a friend who will provide transportation. The individual is not interested in services. Both individuals

			on-site were informed that camping on the train tracks is not permitted.
Sage Street & Railroad	5	0	Clean and Safe Outreach arrived on site for the scheduled clean-up. Individuals declined services.
West 4 th Street & Del Curto Drive	4	0	Clean and Safe Outreach arrived on site for the scheduled clean-up. Individuals declined services.
Siegel Suites	0	1	Clean and Safe Outreach facilitated move-in through Reno Housing Authority Motel Assistance Program at Siegel Suites on March 13.
Email	1	1	Clean and Safe Outreach was working with a client to facilitate a move-in to Cares Campus Permanent Supportive Housing. Clean and Safe requested a verification of homelessness letter from the Sparks HOPE team, as they have been working with the client for two years, which is the minimum length of time needed to work with a client. In result, client moved into Permanent Supportive Housing on March 27.
Siegel Suites - Nevadan	1	1	Clean and Safe Outreach secured a motel room for client through the Reno Housing Authority Motel Assistance program, while they wait for a unit at Village on Sage Street. The individual moved into Siegel Suites - Nevadan on March 13.
North Virginia Street & McCarran Blvd	2	0	Clean and Safe Outreach met with a couple who were camping along McCarran Blvd. The husband has dementia and depends on his wife for care. They recently stayed at Cares Campus; however, the setting was not appropriate for their needs due to the husband requiring continuous support and the couple being separated. They are awaiting disability and Supplemental Security Income (SSI) eligibility. Clean and Safe will follow up with the couple to explore potential housing or program options.
4 th Street & Stoker Avenue	0	0	Clean and Safe Outreach arrived on site to follow up on the encampment from the previous day. Area was clear.

Siegel Suites - Nevadan	2	2	Clean and Safe Outreach arrived on-site to assist a mother and son with moving from the Siegel Suites Nevadan into their permanent housing unit at the Cheryl Apartments.
Trident Way & 9 th Street	1	1	Clean and Safe Outreach arrived on-site with Reno Police to engage with an individual whose vehicle was being towed. The individual shared they are interested in accessing substance use treatment and insurance. Clean and Safe referred the individual to the Cares Campus Resource Center and shared the days Department of Welfare Supportive Service (DWSS) are on-site. Plan is to follow up to discuss treatment programs once the individual has received insurance.
Model Way & Airway Drive	2	0	Clean and Safe arrived on site for clean-up operation with Reno Police. Clean and Safe Outreach spoke with two individuals on-site and they declined services.
Kuenzli Street & Brodhead Park	1	0	Clean and Safe Outreach arrived on-site with RPD to engage with an individual whose vehicle was being towed. The individual expressed initial interest in services, then identified a private property for the RV to be towed to. The individual accompanied the tow truck driver to provide payment for the tow. The individual declined services.
Kuenzli Street & Kietzke Lane	1	0	Clean and Safe Outreach arrived on-site with RPD to engage with an individual whose vehicle was being towed. Services were offered and the individual declined. The individual's stepfather was on-site to assist with moving belongings, but stated he was not willing to take the individual in.
Cadillac Place	0	0	Clean and Safe Outreach responded to a service request requesting outreach. The area was assessed and no individuals were on-site.
Reno Housing Authority, Main Office	1	0	Clean and Safe Outreach meet with Reno Housing Authority staff to review clients enrolled in the Motel Assistance Program and to determine if additional information is needed.

W 4 th Street & McCarran Blvd	1	0	Clean and Safe Outreach responded to a service request requesting outreach. Services were offered and the individual declined. Clean and Safe contacted Veterans Affairs (VA) to request additional outreach, after the individual reported being a veteran.
W 4 th Street & McCarran Blvd	2	2	Clean and Safe Outreach responded to a service request, requesting outreach for an encampment along the Truckee River. Clean and Safe Outreach scheduled a DMV appointment for the couple to get IDs to work on a housing plan.
Lemmon Drive	2	1	Clean and Safe Outreach responded to a service request, requesting outreach at Lemmon Drive. Spoke with two individuals on-site. One individual was referred to Housing and Neighborhood Development for rental assistance and the other individual declined services.
Phone Call	1	0	Clean and Safe Outreach was provided with the phone number of an individual who is living in their vehicle. Services were offered and the individual declined.
White Fir Street	0	0	Clean and Safe Outreach assessed the area and identified two occupied vehicles on-site. Attempted to make contact, but there was no answer.
CARES Campus	1	1	Clean and Safe Outreach and the Sparks HOPE team facilitated a move-in to the Cares Campus Permanent Supportive Housing facility on March 27. Clean and Safe and the Sparks HOPE team were working with this client for the last four years as they camped on the Reno and Sparks border.

Park and River Rangers

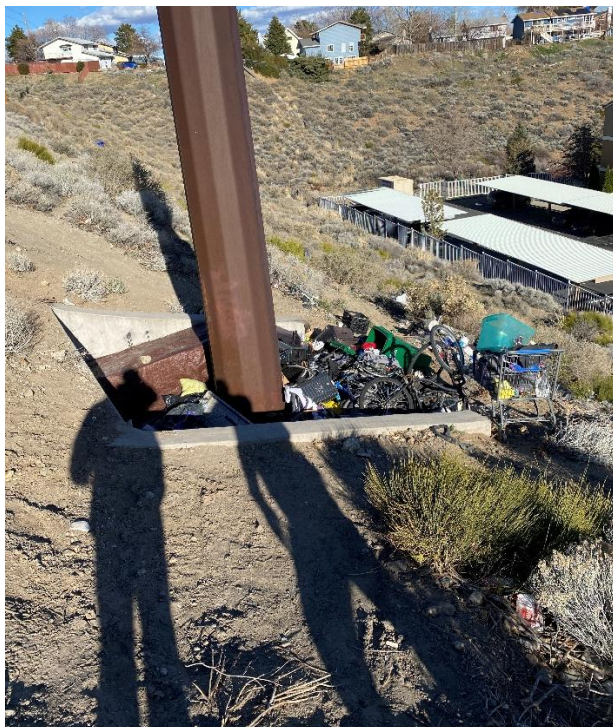

Union Pacific Clean-Up

The City of Reno has monthly coordinated clean-up efforts with Union Pacific. Areas addressed in March include Highland Avenue & Evans Avenue, ReTrac Corridor from Chism Street to Commercial Row, and along the train tracks from Dickerson Road to Del Curto Drive.
