Additional short breaks may be taken throughout the meeting as needed.

Public Comment: Public comment, whether on action items or general public comment, is limited to three (3) minutes per person. No action may be taken on a matter raised under general public comment until the matter is included on an agenda as an item on which action may be taken. Members of the public may participate in the meeting without being physically present by submitting public comment via online Public Comment Form (Reno.gov/PublicComment), or emailing cityclerk@reno.gov. In addition, public commenters may leave a voicemail at (775) 393-4499. Messages received will either be broadcast into the Council Chamber during the meeting, or transcribed for entry into the record. Comments received prior to 4:00 p.m. on March 24, 2020 will be entered into the record. Transcriptions will be given to City Council for review.
