The "Creativity on the River" special event will permit daily set-up by Crafters (defined 1 below) on The City Riverwalk from July 1 to September 30, 2019. Crafters will need to register this application with the City of Reno Arts, Culture and Events office to receive a temporary vendor permit at a cost of \$20 for the duration of this special event. 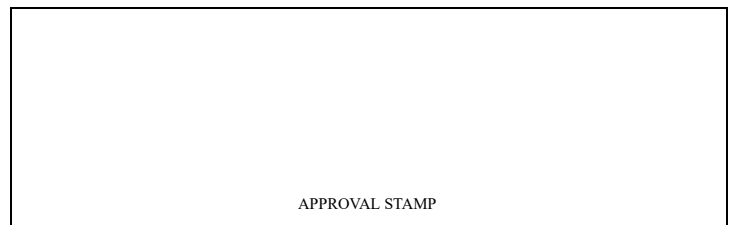
- 1. Definition of Crafter:** Person above shall have constructed by hand the item(s) for sale above, and shall only sell candles, clothing (including hats and shoes), housewares, incense, jewelry, leather goods, lotions, oils, perfume, pottery, metalwork, silver work, stuffed animals, toys, trinkets, and woodwork. Crafter shall not act as a secondhand dealer (RMC Ch. 5.08). Crafter shall not sell or display any of the following items: alcohol, marijuana, marijuana infused products, live animals, food, illegal substances, mass produced items, people, plants, marijuana paraphernalia or tobacco paraphernalia (RMC Ch. 5.19).
- 2. Operation:** Crafter shall operate only within the Special Event boundaries. Crafter shall operate only during Special Event times, which are 8 a.m. to 9 p.m. daily from July 1 - September 30, 2019. Riverwalk Crafter Permit must be visible at all times. Crafter may not set up prior to 8 a.m. and no driving is permitted in the special event venue. Crafter's items left after 10 p.m. on the Riverwalk will be removed by the City. Crafter shall not use sound amplifying equipment (RMC sec. 8.23.085) or other forms used for attracting attention, to include yelling and/or "hawking". No object may be staked or otherwise secured into the ground or secured to or supported by any fixture, amenity or City of Reno right-of-way, including by way of example and not limitation, artwork, benches, buildings, fences, landscaping, light poles, picnic tables, posts or trees.
- 3. Spaces:** There will be 25 spaces made available on a first come, first served basis for Crafters. Crafter shall only operate in one 10 foot x 10 foot space, and the Crafter shall remain contained within one single space daily. The City will not guarantee a space to all Crafters. The City will not guarantee the same space to a Crafter operating on more than one day of the Special Event. Crafters shall not save spaces for anyone. Crafter shall allow the City access to the property for any emergencies, maintenance and repair of anything when necessary. Persons selling expressive merchandise (referenced in RMC Ch. 5.14) or speakers will be able to set up in marked spaces without a licence.
- 4. Compliance with Laws:** Crafter shall comply with all local, state and federal laws. Crafter **MUST** attach Nevada Department of Taxation information to this application.
- 5. Indemnity by Crafter:** Subject to the limitations of applicable law, Crafter shall indemnify, protect, defend and hold harmless City and its governing boards, officers, employees, authorized agents, contractors and subcontractors, and their respective successors and assigns from and against any and all liability, costs and expenses (including defense costs, legal fees, and experts' fees), and claims, losses, liabilities, suits, or actions of any kind (collectively "Claims and Expenses") for damages for personal injury (including death) or property damage, arising out of, relating to or as a result of any negligent or intentional acts or omissions of Crafter or its officers, directors, employees, authorized agents, vendors, contractors, subcontractors, or volunteers, except to the extent such Claims and Expenses are proximately caused by the negligence or willful misconduct of the City or its officers or employees.

I have received and read the Crafters on the Plaza Permit Application and certify I will maintain compliance with these and all regulations to preserve the validity of my permit. If the City finds that I falsified or violated this Crafters on the Plaza Permit Application by not following the above, I understand that the City will immediately revoke my permit.
