SUBJECT: Reno Housing Authority Appointment

This memo serves as formal notice of the appointment of Mariluz Garcia as a Commissioner to the Reno Housing Authority by Reno City Manager Jackie Bryant pursuant to Nevada Revised Statutes (NRS) 315.370.

Mariluz Garcia will fill the vacancy resulting from the resignation of Commissioner Dave Aiazzi and will serve the remainder of the unexpired term, from May 11, 2026 through February 29, 2028.

Legal Authority for Appointment

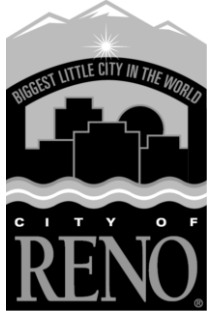
Historically, appointments to the Reno Housing Authority have been brought forward for City Council consideration. However, pursuant to NRS 315.370, the authority to appoint commissioners is vested in the chief executive of the City. Section 2.020 of the Reno City Charter designates the City Manager as the Chief Executive and Administrative Officer of the City.

Accordingly, the City Manager has the legal authority to appoint commissioners to the Reno Housing Authority and to fill vacancies for unexpired terms. This appointment is being made by the City Manager consistent with that statutory authority.

This memo is provided to ensure transparency and to formally notify the City Council and the public of the appointment.

Reno Housing Authority owns and manages public housing units in seven different locations in the City of Reno and Sparks under the Public Housing programs and, through the use of the Neighborhood Stabilization Programs and other funding, owns rental properties specifically targeted for low income households. RHA also provides housing subsidies to low income facilities in Reno, Sparks, and Washoe County through Rental Assistance programs.
